### IMPORTANT INSTRUCTION:

- All candidates applying for the above post should have their MD and their MBBS Degree recognized by Medical Council of India (MCI).
- All candidates applying for the above posts must be registered with Medical Council of India or by a State Medical Council of India.
- Candidates called for interview shall not be paid any TD/DA.
- The upper age limit as on 01.01.2022 is 65 years. However, the age limit may be relaxed upto 70 years with specific approval from the Competent Authority.

### **MEDICAL FITNESS:**

The applicant should have a sound health. Before joining, selected candidates will have to undergo medical examination by the Company's Authorized Medical Officer and the appointment shall be subject to meeting the health standards as prescribed by the Company.
