#### I. COMPANY PROFILE

Eastern Coalfields Ltd (ECL), a subsidiary of Coal India LImited was incorporated on 1st November, 1975 taking over 414 mines vested with Eastern Division of Coal Mines Authority Limited (CMAL) and the company commenced its commercial operation from that date. It operates in the states of West Bengal and Jharkhand. There are 14 number of operating areas with 80 number of working mines, 48 being underground mines, 23 opencast mines and 9 mixed mines. The production of coal for the F.Y. 2021-22 is 32.43 MT, with OB removal of 119.27 M.Cum. and off-take of 36.02 MT.

ECL is a Schedule 'B' CPSE in Coal and Lignite sector with the administrative jurisdiction of Ministry of Coal.
