**PERIOD OF ENGAGEMENT:**

The Specialist will be engaged initially for a period of 03 months, which may be extended further for two years based on the requirement of the Hospital and performance of the Specialist. Performance of the Specialist will be assessed by the Head of the Hospital during the said period. They will be reporting to the Head of the Hospital.

In addition to the aforesaid remuneration per visit, the selected candidate will be eligible for Conveyance reimbursement of Rs. 12/- per km. However, minimum conveyance amount will be Rs. 250/- per visit).
