## **I. QUALIFICATION & EXPERIENCE (exp. as on 31/08/2022):**

- Diploma in Nursing and Midwifery (3 years course) with Registration as 'A' grade Nurse from any of Central / State Nursing Council with minimum 2 years post qualification experience in a recognized Hospital / Institution / Organization.
- B.Sc. (Nursing) with Registration as Nurse from any of Central / State Nursing Council with minimum 2 years post qualification experience in a recognized Hospital / Institution / Organization.
- Nursing 'A' Certificate with 3 years post qualification experience in a recognized Hospital / Institution / Organization.
- Nursing Assistant Class III & above from the Armed Forces with minimum 2 years post qualification experience in a recognized Hospital / Institution / Organization.

## **II. SELECTION CRITERIA:**

Candidates will be allowed only after registration and followed by successful document verification. Following is the selection criteria and qualifying marks in interview shall be 18 marks.

## **III. FINALIZATION OF MERIT LIST:**
