NOTICE INVITING APPLICATIONS FOR ENGAGEMENT OF EXPERIENCED PERSONNEL ON CONTRACT BASIS (GLOBAL EXPERTS)

MECON Limited, a Miniratna Schedule "A", Public Sector Enterprise under Ministry of Steel, Government of India has taken up **Operations and Maintenance (O&M)** of 3 MTPA Integrated Steel Plant of NISP (NMDC) at Nagarnar (Chattisgarh).

MECON Limited invites applications from experienced personnel of India & abroad for short listing as **Global Steel Plant expert**.

The applicants should ensure that such Engagement does not interfere or infringe with any of his commitment(s)/present engagement(s) and it will be the sole responsibility of the applicant to take required clearances from his present engagement(s)/ Employer(s).

The **Global Steel Plant expert** shall be required to sign a Secrecy Bond/ Confidentiality Agreement prohibiting any divulgence to third party, in whatsoever manner, of the details of the assignment to be contracted by him.

The Engagement of Experts shall be strictly governed by extant applicable laws/ rules & regulations of Govt. of India, in force.

Broad domain expertise sought is in the following areas:

Area of Expertise

- Blast Furnace (including auxiliary facilities like Pig Casting Machine, Pulverised Coal Injection, etc.)
- Steel Melting Shop having BOF / LF
- Continuous Casting Machine & Thin Slab Caster
- Hot Strip Mill

1. Experience:

Desirous candidates should possess minimum 35 years relevant experience in operation of Integrated Steel Plant of capacity of 3 MTPA or above out of which at least 20 years shall be in the area applied by the Applicant. Candidates should be professionals having global experience (retired also eligible) who were under direct employment of any Public/ Private Company and are capable to oversee/ manage the entire envisaged activities of operation & maintenance to achieve the adoption of the best practices for trouble free plant activities.

In order to substantiate Global experience, the Applicant shall submit proof of having worked in integrated steel plant of capacity 3 MTPA (or above) located in atleast 2 different countries.

The candidates from countries having geographical border with India are not eligible to apply against this requirement.

2. Educational Qualification:

- For Indian experts: Degree in Engineering / AMIE (or equivalent).
- For Foreign experts: Degree in Engineering.



3. Engagement

Applicant's engagement shall be for 3 MTPA Integrated Steel Plant of NISP, Nagarnar (Chattisgarh), India.

4. Age Limit & Tenure of Engagement

The selected Applicant will be engaged for a period of 03 (Three) years with provision for extending the engagement for further period of one year at a time for maximum 02 (Two) such extensions. However, the engagement shall automatically cease to exist upon the incumbent attaining 70 years of age.

For Foreign experts, the minimum continuous availability in India shall be three (03) months.

5. Method of Selection for Engagement

- Personal interaction as required by MECON.
- Candidates are required to furnish two (02) References (along with details of organization / designation last held / contact / email details) who know them professionally & can recommend their candidature.
- MECON reserves the right to adopt any other method including ON LINE MODE of Interaction with applicant (if required).
- The selection shall be based on academic qualification, experience and expertise.

6. Consolidated Emoluments & Other benefits

The selected experts shall be paid consolidated contractual fee as mentioned below;

- For Indian experts: Maximum Rs.500000 (Rupees Five Lakhs only) per month
- For Foreign experts: Maximum Rs.750000 (Rupees Seven Lakhs Fifty Thousand only) per month

All payments shall be made ONLY in INR. The contract fee shall be finalized depending upon candidates' experience, expertise & qualification. The payment of contract fee shall be released to the Expert after certification of concerned authority of MECON for the services rendered by the Expert. Applicable taxes / duties in India shall be levied & Experts to be engaged should be in possession of GSTIN number and PAN (Permanent Account Number) issued by the competent authority of Government of India, as applicable for professionals.

7. Medical Examination:

The selected candidate is required to enter into Contract with MECON. Before rendering the services, the selected candidates will have to undergo medical examination. The engagement of the selected candidates shall be subject to being found medically fit.

Further, the selected candidates should possess a valid Medical Insurance for the duration of engagement.

8. Travelling Allowance & Other facilities:

The following shall be provided/ reimbursed by MECON:

- (a) To & fro Economy class flight tickets upto the nearest Airport at the time of joining.
- (b) Every subsequent six months till cessation of his engagement, to & fro Economy class flight tickets / 2 AC train tickets to Indian airport for taking the flight abroad. Such re-imbursement shall be limited to the air ticket expenditure upto the airport nearest to his hometown.
- (c) Transit taxi charges, as applicable on actuals at the time of joining & every subsequent six month till cessation of his engagement.
- (d) Single room accommodation at Nagarnar (Chhatisgarh, India) at Hotel / Guest House as available.



- (e) Local transport at Nagarnar (Chhatisgarh, India).
- (f) Medical facility limited to First Aid only as available at Plant premises (no other Medical Insurance/ facility shall be provided by MECON)

 - (b) Scanned copy of signature with Blue / Black ink pen in jpg/jpeg format (size not exceeding 40 KB).
 - (c) Self-Attested scanned copies of the documents in pdf format as follows:
 - i. For age proof:- Date of Birth (Educational certificates or mark sheet not below Matriculation where DOB is mentioned/ Birth certificate issued by the Govt. Authority /PAN/ Aadhar card/ Voter ID/ Passport/ Driving License).
 - ii. **For qualification: -** Final/ Provisional Certificate or final consolidated mark sheet wherein passing of degree is mentioned. It is to be noted that for AMIE or equivalent qualification, passing certificate should be provided.
 - iii. For work experience certificate: Experience certificate issued by the employer or Self certified experience certificate (as mentioned in the application form) where the document should clearly prove the period claimed (from-to). Please ensure that the requisite years of experience is post qualification.
- 3. The candidate is required to mention the name, position held in the organization, Postal address for correspondence, email address and mobile number of 2 (Two) persons of eminence who know them



professionally & can recommend their candidature. The above information is required for the purpose of verification of experience / professional expertise mentioned by the candidate in their application.

NOTE:
