certificate and latest passport size photograph at the time of written test for
verification. Candidates those who fail to submit original certificates for verification will
not be allowed for written test.

- The candidate should hold Degree certificate (atleast Provisional certificate) in original in r/o. Graduation/Professional courses. (website results/Awaiting for results candidates will not be allowed/considered).
- 4. No objection certificate from the employer, incase he / she is employed else where.
- 5. No TA/DA will be paid to any candidate to attend the Written test.
- 6. The above position is purely on temporary basis and is co-terminus with the project.
- 7. There is no provision of re-employment after termination of project. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute.
- 8. The selected candidate will be working on whole time basis and will not be allowed to register himself/herself for any academic programme viz.Ph.D. etc.
- The candidates appearing for the written-test cum interview should follow Social Distancing inside the campus till the written test procedure gets completed.
- 10. The candidates should wear mask till the completion of written test procedure.
- 11. The written test cum interview will be conducted by strictly following COVID 19 guidelines given by Tamil Nadu state government / Government of India.
