1.Consolidated Monthly Remuneration:

Monthly remuneration of the retired Railway Supervisor should be determined as per Rly Brd's lr. No.E(NG)II/RC/CORE/- dt. 24.10.2019 (PBC No 258/2019).

2.Eligibility Criteria:

Sl. No.	Subjects	Remarks
1	Who are eligible to apply	1.The retired railway supervisors at the time of retirement should have worked in the capacity of SSE/JE (works), SSE/JE (D&D), SSE/JE(P.Way) with minimum of 10 years of experience and minimum qualification of Diploma in Civil Engineering or Degree in Civil Engineering. 2.Those who had retired on superannuation alone are eligible. (VR/Compulsorily Retirement/Removed/Dismissed are not eligible)
2	Medical Fitness	Must be found medically fit in appropriate category.
3	Age limit/Period of engagement	Must be within 64 years 6 months of age on the closing date of notification. Those re-engaged shall continue up to the last day of the month in which he/she attains the age of 65 years, i.e following the same system as that of normal retirement.
4	Documents to be attached	1.Copy of Service Certificate 2.Copy of Pension Payment Order (PPO) 3.Copy of Bank account details/Aadhaar/PAN 4.Two copies of recent passport size photo(Not later than 3 months)

3.Procedure for Re-engagement:

Shortlisted RRS (Retired Railway Supervisor) will be called for document verification, if found satisfactory then will be sent to fitness in appropriate medical category. A screening will be conducted to assess suitability/safety records of the RRS by a committee of JAG level officers.

4.General Conditions:

- a. Eight days leave (one pro-rata basis) in a calendar year will be admissible.
- b. The RRS will not have the right for continuity/extension of re-engagement.
- c. The service of re-engaged retirees will be terminated by giving notice of 14 days on either side.
- d. The administration is at liberty to terminate the service of the re-engaged personnel in case their performance is found to be unsatisfactory. However, when RRS is found to be mentally or physically incapacitated and in case of gross negligence/misconduct/misbehaviour/irregularities, the re-engagement may be terminated with immediate effect.
- e. The service of the re-engaged personnel will be terminated on attaining the age of 65 years.
- f. In case of absence for duty, proportionate amount of remuneration per day will be deducted. If full time RRS are on unauthorized absence beyond 3 days, their re-engagement will automatically be terminated.
- g. The re-engagement is subject to the orders issued by Railway Board from time to time.

5.How to Apply:

Filled applications may be sent along with necessary documents to Divisional Personnel Officer / Madurai Division, PIN-625016, as per proforma in Annexure-I either in person or by post.
