Delhi Metro Rail Corporation (DMRC), a Government owned company, has been set up for implementation and operation of the rail-based Mass Rapid Transit System in Delhi. The company intends to appoint the following official:

Type of Recruitment: Direct Recruitment/Deputation basis

Date of Vacancy (DOV): Immediate

Scale of the Post: Rs.180000 - 340000 (IDA) and other allowances/perks/privilege.

Duration of Appointment: The appointment will be on a contract basis presently, for a period of

5 years, or, the date of superannuation, whichever is earlier

#### 1. Job Description and Responsibilities

The incumbent of the post shall be a member of the Board of Directors of DMRC and will report to the Managing Director of the company.

He/She shall be responsible for operations, commercials, safety and security of the Metro Sections opened for revenue services. He/She will closely associate with the Project Wing for planning of the new metro lines. He/She will be responsible for maximizing revenue through Fare Box Collections and Non-Fare Box viz., Advertisements, Property Business and any other activity, for generation of Non-Fare Revenue. He/She shall look after the functioning of the Delhi Metro Rail Academy (DMRA). In addition, he/she will also be responsible for the O&M activities being executed / to be executed by DMRC, as Consultancy work for other Metro Systems in India and Abroad.

#### **Desirable:**

1. Experience of operations, property business and development of Modern urban rail-based Transportation system.
