- All the candidates are requested to appear for document verification along with filled application form as attached within the scheduled time (09.00AM – 11.00 AM) with proper protection like wearing face mask and carrying sanitizer and maintaining social distance. No candidate will be entertained to attend document verification after 11.00 AM on scheduled date as mentioned above.
- Only those candidates whose documents are verified will be allowed to attend walk-in interview.**
- Dean, ESIC Medical College & Hospital reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all posts without assigning any reason.
- Change in date of interview, etc. if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information relating to the recruitment/engagement. Other terms and conditions as mentioned in **Annexure 'A'**.

The performance of the candidate in the interview will be the sole criteria for selecting the candidate for the respective post. Mere participation in the screening test will not confer any claim for the post.

**Eligibility criteria and other Important Information relating to the contractual engagement is as follows:**

**Homeopathy Physician:**

**A. Essential Academic qualification to be eligible for engagement is given below:**

- (i) Degree in Homeopathy of a recognized University or statutory State Board or Council or equivalent recognized under the Homeopathy Central Council Act, 1973 (59 of 1973).
- (ii) Enrolment on the Central Register of Homeopathy or State Register of Homeopathy.

**B. Age Limit:** Not exceeding 35 years as on date of reporting for interview.

**B. Emoluments: Rs. 50,000/- per month (5 hours per day and six days a week).** No other allowances in any form shall be admissible.

**General Terms and Conditions**

**Terms of Contract:**

1. The above engagement will be purely on a part time contractual basis and shall be valid for a period of two years subject to renewal every year based on the work performance and accepted by either parties or appointment of regular incumbents whichever is earlier.
2. The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning any reason.
3. Since the engagement being part time in nature, the incumbent is not eligible for any kind of leave benefits. In case of days of leave availed by Homeopathy Physician, the remuneration will be reduced proportionately.
4. Rules for Reservation will be implemented as per Govt. of India instructions.
5. The Appointment shall not confer any right or preference for regular appointment.
6. The Appointment is subject to Medical Fitness.
7. No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
8. Candidate must be registered with Enrolment on the Central Register of Homeopathy or State Register of Homeopathy.
9. Candidate in the Government Service should submit "No Objection Certificate from the employer at the time of Interview. And in case of selected for engagement they have to resign from the Government Service.
10. The candidates who are already employed must produce relieving order from the previous employer at the time of joining / NOC for taking up Part Time engagement with ESIC.
11. No TA/DA will be admissible for interview or joining.
12. The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.

13. The Homeopathy Physician so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
14. The doctor at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
15. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
16. Selected candidate will have to join duty on or before the date indicated in the offer of appointment/engagement likely to be issued.
17. The Homeopathy Physician so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-**
18. **On selection, candidate has to open an SB Account in the State Bank of India (Any branches) [This is applicable to cases where SB account is not held in State Bank of India]**

A Demand Draft for Rs.500/- (as applicable) in favour of 'ESI Fund Account No.1' drawn on any scheduled bank payable at Chennai has to be submitted along with application form at the time of document verification cum walk-in Interview.

**Note:**

- (i) Fee once paid will not be refunded under any circumstances.
- (ii) Only Demand Draft drawn on any Scheduled Bank will be accepted. Application fee Paid by any other mode will not be accepted.
- (iii) The Demand Draft must be issued after the date of issue of this advertisement.

**The following testimonials should be submitted at the time of walk-in-interview:**

- (i) Two copy of recent self-attested passport size photograph.
- (ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience etc.
- (iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience etc., should be submitted at the time of interview.
- (iv) Certificate issued by competent medical board in respect of Persons with Bench Mark Disabilities.

- (v) Candidates seeking reservation benefits under SC/ST/OBC/EWS/PWD category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instructions issued by Govt. of India. They should also produce original certificates in the prescribed format of Govt. of India in support of their claim.

**Selection Procedure:**

- (i) The selection will be made on the basis of performance of the candidate in interview before the Selection Board.
- (ii) Result will be communicated through e-mail and will be displayed on website.
- (iii) Selected candidates will have to join immediately after receipt of the offer of appointment.

**General Instructions:**
